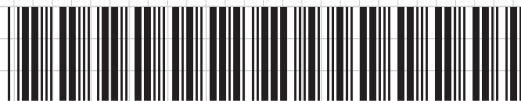

Who must file a Form D-40B?

- Any nonresident of DC claiming a refund of DC income tax withheld or paid by estimated tax payments.
A nonresident of DC is anyone whose permanent home was outside DC during all of 2007 and who did not live in DC for a total of 183 days or more during 2007.
A joint request for refund is not permitted.

How will we respond to your request?

- We will send you a refund check for the amount of your request if we determine you were a nonresident during 2007; or
Based on the information you provide, we may determine that you qualify as a DC resident. If so, we will send you a notice of your residency status and require that you file either a D Form D-40 or D-40EZ to request a refund.
