Form FP-129A  
Extension of Time to File DC Personal Property Tax Return

A 3-month extension of time to file will be granted if you properly complete and timely file this FP-129A form together with full payment of any tax due. If you are granted an extension of time to file, you must attach a copy of this form FP-129A when you actually file your personal property tax return or report. The request for an extension of time to file must be submitted no later than the due date of the return or report.

- Enter your federal employer identification number (FEIN) or your social security number (SSN)
- Fill in the oval for the identification number you entered.
- Enter your business name and mailing address.
- Enter the amount you are paying by check or money order (do not send cash)
- Make check or money order (US dollars) payable to the DC Treasurer.
- Write your FEIN or SSN and tax year on your check or money order.
- Staple your payment to the FP-129A form.
- Mail the FP-129A form to the:

Be sure to sign and date this form.

Notes:

- **If the amount of the payment due for a period exceeds \$5,000, you must pay electronically.** Visit [www.taxpayerservicecenter.com](http://www.taxpayerservicecenter.com) for instructions.
- **For electronic filers**, in order to comply with new banking rules, you will be asked the question "Will the funds for this payment come from an account outside of the United States?". If the answer is yes, you will be required to pay by money order (US dollars) or credit card. Please notify this agency if your response changes in the future.
