





Follow the step-by-step instructions to register. The last step of registration is the "Certification." Once it is submitted, a confirmation number will generate:




Example of the "confirmation number": (You will receive an email containing your registration letter.)


Thank you for registering for the District of Columbia's Over the Counter Sale.

All payments must be made to the D.C. Treasurer by cash, certified check, cashier's check, postal money order, or electronic wire. Pursuant to D.C. Code § 47-1353, payment of the amount for which the real property was originally bid off, plus interest thereon is due immediately upon purchase of an eligible property or properties through the Over the Counter Sale.

You are required to create an account at MyTax.DC.gov in order to manage your purchases electronically. It will provide such information as deposits made, your tax sale portfolio, and the status of any refunds.


Sample image of the activated Over-the-Counter purchaser account number:






Now it's time to view the available liens for purchase.

Select the "View Other Options" hyperlink:




Select "Over the Counter Purchase": (This will display the available liens to purchase for OTC.)






Select the check box for liens you wish to purchase, then click on "Next":




Based on selection(s), the "Over the Counter Purchaser Summary" will display: If found to be accurate, click "Next":






The next screen will display important information regarding lien purchase(s) and requires an attestation. Click "Next":




The following display is the final certification requiring review and submission:






A "Confirmation" page is displayed containing information on payment: (Payment voucher with the property totals can also be viewed by selecting "Printable View.")
