 - Pay with eCheck
 - Make an electronic payment from your bank account at no additional fee. Payments can be scheduled up to one year in advance.
 - Pay with Credit / Debit Card
 - Make a payment using your credit or debit card. A convenience fee of 2.5% will be charged by the credit card processor for each payment.

2. To register a new business, click **Register a New Business: Form FR-500**. If you are unable to complete your application, it can be saved and completed at a later time.
3. To check your refund status, click **Where's My Refund?**

4. The **Log in/Sign Up** panel allows you to log into the system and view your tax account information.
5. **Businesses** - use the links located in the center of the page. Click **Current & Prior Year Tax Forms** to go to the District of Columbia OTR forms site. Click **Modernized e-File** for information regarding the federal and state e-file program. Click **Retrieve a Saved Submission** to search for an existing submission using your email and confirmation code. To register a special event, click **Register a Special Event – Form FR-500B**. Government employees on official government business may click **Request Government Exemption** for sales and use tax exemptions. Click **Exemption/Certificate Search** to see whether a Sales and Use Tax Certificate or Exemption Certificate is valid.
6. **Businesses** will find links to file and pay extensions under **File and Pay Now**.
7. **Individual** taxpayers - use the links located on the right side of the page. Click **Current & Prior Year Tax Forms** to go to the District of Columbia OTR forms site. Click **DC Free File / DC Fillable Forms** for Individual Income Tax Return electronic filing options. Click **Verify My Return** if you received a notice from OTR that your return was selected for further review. Residents who park their motor vehicles or trailers within one-half mile of their residences for non-commercial purposes, may click **Request Residential Parking Exemption** for exemption on DC sales tax on parking.
8. **Individuals** will find links to file and pay extensions under **File and Pay Now**.
9. Taxpayers with an Electronic Taxpayer Service Center (eTSC) login will be unable to transfer log-in credentials to [MyTax.DC.gov](https://www.mytax.dc.gov). Click **Sign up to use MyTax.DC.gov** and register for an account to [use the full range of services](#).
10. Additional information and navigation assistance can be found under the **QUICK LINKS** section.
11. You can make fast and easy payments using the **Quick Payments** section without logging in. Payments can be made by eCheck, credit or debit card. The **Pay with eCheck** feature allows you to schedule payments up to one year in advance with no additional fee. You may also use **Pay with Credit/Debit Card**, you will be charged an additional 2.5% convenience fee by the credit card processor.
