The Office of Tax and Revenue's (OTR) web portal, MyTax.DC.gov, makes it simpler, faster, and safer to handle your taxes online. See the chart below for supported tax types and activities.



- Access your tax account(s) and view correspondence 24/7
- "Go Paperless" option
- Schedule your payments up to one year in advance for individuals and businesses
- Use the portal's streamlined capabilities to file your business's tax returns, estimate, or extension payments in advance



- Update your account information quickly (e.g. mailing address)
- Save your bank account information in your profile to make future payments faster
- Use the portal's web message feature to contact customer service for a swift response to your tax questions



- Rely on the protection of your data, encrypted to industry standards using an SL/TLS certificate
- Use credit cards to make secure payments
- Approve third parties (e.g. tax preparers) to access and manage your tax account(s)
